Decision no. 169/2025 of the Warsaw University of Technology Rector of 1 August 2025

amending decision no. 88/2025 of the WUT Rector on the rent for accommodation in halls of residence of the Warsaw University of Technology in the academic year 2025/2026 and during the holidays in 2025

Pursuant to Art. 79 section 2 point 6 of the Act of 20 July 2018 Law on Higher Education and Science (Journal of Acts of 2024 item 1571, as amended), in connection with § 8 section 2 of the Regulations on allocating places in Warsaw University of Technology halls of residence and rent for accommodation, annex to Regulation No. 4/2025 of the WUT Rector of 28 January 2025 on introduction of Regulations on allocating places in Warsaw University of Technology halls of residence and rent for accommodation, it is hereby decided as follows:

§ 1

The following amendments to Decision No. 88/2025 of the WUT Rector of 12 May 2025 on the rent for accommodation in halls of residence of the Warsaw University of Technology in the academic year 2025/2026 and during the holidays in 2025, are introduced:

1) point 11 in the table in § 1 section 1 shall read:

From 1 July 2025 to 30 June 2026, the reservation fee referred to in § 9 section 1 of the Regulations on allocating places in Warsaw University of Technology halls of residence and rent for accommodation, annex to Regulation No. 4/2025 of the WUT Rector, shall amount to:

- 1) PLN 500.00 for WUT students and doctoral students, participants of courses organized by the WUT Foreign Language Centre, and for students and doctoral students from other universities with which the Warsaw University of Technology concluded an agreement on accommodation in WUT halls of residence, as referred to in § 2;
- 2) PLN 1000.00 for other persons.";

3) point 11 in the table in § 6 point 2 shall be repealed.
